

RELEASE/WAIVER OF LIABILITY AND INDEMNIFICATION AGREEMENT

The undersigned participant in Camp Keshet ("Camper"), and (if the Camper is under 18) his or her parents or legal guardians, individually affirm and agree that:

1. I fully understand and acknowledge that hazards, dangers, and other risks are inherent in participating in the activities of Camp Keshet, located at Tel Hai Camp and Retreat, 31 Lasso Drive, Honey Brook, PA 19344-9261, and that such participation may result in injury or illness to the Camper.
2. Such activities include, but are not limited to, swimming, hiking, fishing, boating, archery, bonfires, horseback riding, hayrides, running, jumping, athletic individual and team sports, frisbee, team games, capture the flag, and other normal camp activities. I also give Camp Keshet, its assigns, licensees, and legal representatives, the irrevocable right to use my picture, portrait or photograph in all forms, media and manners, including any and all audio recordings of the Camper's voice, without restriction as to changes or alterations, for advertising, trade, promotion, exhibition, or any other lawful purposes.
3. I understand that these risks and dangers may be caused by negligence of participants in the activity, negligence of others, accidents, breaches of contract, forces of nature, or other causes.
4. I understand that there is to be no diving into the pool at Tel Hai Camp & Retreat.
5. In consideration of the Camper's participation in Camp Keshet, and intending to be legally bound, I hereby, for myself, my heirs, executors, and administrators, assume all risks and dangers and voluntarily agree to release, hold harmless, defend, and indemnify Tel Hai Camp & Retreat, L'Chaim Messianic Congregation, Son of David Congregation, Emmanuel Messianic Jewish Congregation, Congregation Rosh Pina, Sar Shalom Fellowship, Ohev Yisrael Messianic Jewish Congregation, any other congregation, Chosen People Ministries, the Christian & Missionary Alliance, any other "para-church" organization and their respective employees, volunteers, officers, agents, and attorneys, from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services, or otherwise, which may arise out of the Camper's participation in the activities of Camp Keshet, which may hereafter accrue to me against the same, or which may arise out of the Camper's traveling to or participating in and returning from any activity associated with Camp Keshet, including the traveling to and from Camp Keshet to attend and leave Camp Keshet at the beginning and ending of Camp Keshet. This Waiver/Release/Indemnification is understood to also be in effect with respect to, and to include any persons who may be engaged in, the transportation, treatment or attending to, or accompanying of any Camper to any medical treatment facility on or off of the camp property, on the same basis and terms as stated above.

Any/all Volunteer or Paid Staffers of Camp Keshet and/or Tel Hai Camp & Retreat and/or any congregation and/or any "para-church" organization, are hereby fully released and/or absolved of any/all liability due to any/all weather-related and/or any/all other "acts of God", events, causes, results thereof, etc., which are not under the control of any/all Volunteer or Paid Staffers of Camp Keshet, Tel Hai Camp & Retreat, any/all congregations and/or any/all "para-church" organizations. Any/all such persons and/or personnel are held released and waived from any/all liability.
7. I hereby agree and acknowledge that any claim or dispute arising from or related to the Waiver/Release/Indemnification granted herein or the relationship of the parties in any respect thereto shall be brought within 12 months of any occurrence or discovery (or forever waived) and shall be settled only by mediation, or, if necessary to resolve the dispute, legally binding arbitration

in accordance with the then-current Rules of Procedure for Christian Conciliation of the Institute for Christian Conciliation (406-256-1583), a copy of such rules shall be made available upon request. Judgment upon a mediation or arbitration award may be entered in any court otherwise having jurisdiction and such mediation or arbitration is the sole remedy and is non-appealable.
