DONATE BY CHECK: In this increasingly electronic world, many businesses have moved away from paper. But fear not—we always accept checks! Please make your check payable to “Chosen People Ministries,” and if you have a specific purpose or missionary in mind, please include that in the memo.



DONATE BY PHONE: You can speak directly to one of our donor care specialists by calling 1-800-969-6850 and donate by credit card. This option also allows you to have a friendly conversation and share prayer needs.



GIVE SECURELY ONLINE: You can make a gift online by credit card on our website—chosenpeople.com/donate.



RECURRING DONATIONS: You can create a recurring donation that is either deducted from your checking account or placed on a credit card. To start your monthly giving, complete the Watchmen for Jerusalem section on the enclosed reply slip and return it in the enclosed envelope.



STOCKS, BONDS, AND MUTUAL FUNDS: When you give stocks, bonds, and mutual funds, especially long-term appreciated securities, you can often save on your taxes and can contribute more to the ministry based upon the advantageous United States tax codes.¹ When we receive these financial instruments, we sell them at market value so the funds can go immediately into the work of our ministry.



GIFTS OF REAL PROPERTY: Donating non-cash assets such as business interests, real estate, cars, boats, jewelry, and other items is another way to bless Chosen People Ministries. GIFTS FROM YOUR IRA: If you are 70½ years of age or older, you can donate up to \$100,000 from your IRA distribution and not add a penny to your taxable income. Even if you do not itemize deductions, giving in this way allows you to receive a tax benefit for your generosity. Please consult your IRA custodian for the necessary forms to begin the process.



CHARITABLE GIFT ANNUITY: Another way to give and make an impact in Jewish evangelism is by establishing a Charitable Gift Annuity at Chosen People Ministries with a gift of \$10,000 or more. You will also receive the tax benefit of your investment right away—an immediate charitable deduction and a steady income for your lifetime that will not fluctuate with the stock market.



LIFE INSURANCE: If you find that the cash value of a life insurance policy is no longer necessary, you can donate the policy to Chosen People Ministries for immediate use in Jewish evangelism.



GIVING FROM YOUR DONOR ADVISED FUND: Now is a great time to distribute grants from your DAF to Chosen People Ministries. These funds are already set aside for ministry and your select charities, so you can give freely without touching your ready capital.

¹ You can deduct the fair market value of the securities against up to 30 percent of your adjusted gross income, and any excess deductions can be carried forward into as many as five additional tax years.
